- (vii) Taking decisions regarding Games Village design, decision on parameters and requirements in the Greenfield stadiums based on Consultant's advice,

- (viii) Approval of RFP for selection of developers for Games Village and Greenfield stadiums,
- (ix) Evaluation of technical bids for developers for Games Village and Greenfield stadiums,
- (x) Offering advice to the Executive Committee/Governing Body/Government of Kerala on selection of developers for Games Village and Greenfield stadiums,
- (xi) Monitoring & evaluation of progress of developers of Games Village and Greenfield stadiums, etc.
